BY REDUCING THESE FINANCIAL BARRIERS, THE PROGRAM ENABLES YOUTH SAILORS OF VARYING ECONOMIC BACKGROUNDS TO PARTICIPATE IN ORGANIZED SAILING INSTRUCTION, TRAINING, AND REGATTAS AT THE LOCAL, REGIONAL, AND NATIONAL LEVELS.
